- In 2004, CSPC Identified the need to support childcare providers as well as parents to close the opportunity gap

COLORADO STATEVIDE PARENT COALITION

- PASO trains informal childcare providers to create high-quality-learning opportunities for the children in their care.
  - CSPC has trained over 1300 providers since 2006
  - 120 hours of instruction over the course of 15 weeks
  - Three Home visits to monitor for improvements in Childcare environment
  - Covers the six core competencies of the Child Development Associates (CDA)
  - Graduates are qualified to apply for the CDA
  - PASO is culturally competent

## Child Development Associates

- Most widely recognized child development certificate
- Must renew every three years
- Requires competencies and requirements beyond those of the State licensure program.

#### PASO is an evidence-based program


Results: Statistically significant positive improvement of 11 NCE points

 11 NCE points translates to an increase from 6<sup>th</sup> percentile to 17<sup>th</sup> percentile in DP-3 Measure

Results: between 78 and 75% of PASO graduates apply for their CDAs

#### Challenges for FFN providers:



PARENT COALITION

- Arbitrary requirements for home-childcare providers
- Low threshold for number of children providers can care for
- No benefits, i.e. health insurance, etc.
- No subsidies
- High overhead cost for FFN providers with very low ROI: liability insurance, cost of meals
- Saying no to families with children in need of care

#### Solution: From Providers



- Add Childcare exemption to HB 1023
- Revise the home safety requirements for homebased childcare
- Create a group FFN provider liability plan that providers can buy into at a reduced rate
- Develop partnerships with grocery stores and food banks to support the healthy nutrition for FFN providers

#### Growing Readers Together (GRT) Grants

- Small awards (\$5,000 \$8,125)
- Support iterative development
- Partnerships & outreach key activities
- Require 20% of funds used for "give-away" materials
