### **Overview of Key Opportunities for CO-ECCS**

Dawn Newby and Kendra Neumann from Colorado Health Institute (CHI) shared key opportunities identified in the project's System Asset and Gap Analysis (SAGA)

Attendees shared initial thoughts and reactions to the opportunities outlined. Thoughts shared:

- Consideration of specificity in opportunities
  - Ex: Addressing gaps in sign-ups for benefits available to families and young children including Medicaid & WIC
- Consideration for other programs and plans as resources. Including:
  - AAP (American Academy of Pediatrics) CO chapter strategic plan
  - RAE's KPIs for birth through 3 months in getting EPSDT benefit (screening) & current work presenting on Title V
  - Healthy Child Care Colorado connections with plans from school nurses/CDE & Children's Hospital (and other hospitals) community assessments
  - IIK's REACH Referral System for Nurse Family Partnerships and Child First
  - Family Connects & its alignment with RAE goals

### **Colorado Shines Brighter B-5 Strategic Plan & Integration of the CO-ECCS Strategic Plan**

Lindsey Dorneman presented on the *Colorado Shines Brighter Birth through Five Strategic Plan* (CSB B-5 SP) and its update process.

Common themes that emerged in reflection on the key opportunities shared earlier in the meeting:

- Ilesha Mitchell: Reflecting on ECCS being incorporated in CSB - highlighted that Mental Health is not represented, it is a priority for Invest In Kids, and especially for infants because they are often not included in mental health strategy.
- Christal Garcia - Mental Health strategy, especially in being inclusive and responsive to BIPOC families and integrating family and provider (dulas & promotoras) voices in understanding barriers.
- Sandy Stenmark (in chat): Funding for the community workforce is critical
