- Going to have a larger report about the pilot
- Overlap with Office of eHealth Innovation Social Health Information Exchange (SHIE) project
- Feedback gathered on the 1-pager

Questions re: the DSR e-Referral Pilot Project

- **Q:** Is it specific to medical providers or to other providers?
 - o A: The pilot came out of a larger project to test success between healthcare providers

and Early Intervention (EI)

- **Q:** Are mental health providers included?
 - A: Not yet

Comments re: the DSR e-Referral Pilot Project

- Overall excitement around taking this pilot statewide and seeing a coordinated system
- Getting family feedback is important, especially in the child welfare system

Suggestions re: the DSR e-Referral Pilot Project

- Including mental health providers can be main contact for families in child welfare, can determine neglect vs. developmental issues
- Ability for Doulas to access information to better help families?
- Inclusion of outside hospitals/ health providers
- Connection to SNAP, Medicaid, and WIC

Early Childhood and Health Care Partnerships Implementation Team

Debriefed P-3 Policy Center presentation

- At this time, no sub-state level data available
- PN-3 Policy Clearinghouse has information on policy that has differential impacton subgroups
 - Much more work to do on Birth Equity
 - Evidence-based home visiting programs were selected because of their emphasis on parenting outcomes.
 - o Early Head Start (EHS) is standalone because funding and evidence base are different
- State examples:
 - WA state using Preschool Development Grant (PDG) to address paid family leave,
 SNAP and child care
 - WV doing categorical eligibility between SNAP and child care
- Why do we have 6 month eligibility on SNAP?
 - o Perhaps a welfare mentality to touch base with them every 6 months
 - This would require only a rule change
 - Feds require check in at 6 months, but content/ease of check-in is determined by states (i.e. interview vs. quick email/call)
 - o Denver Human Services provides services onsite
- Feds have shared CO is out of compliance with <u>CCCAP</u> rates
 - Concern about tradeoff serving providers/children well versus serving more children
 - CO approaches:
 - Advocacy group forming to figure out how to address the increased cost
 - CDEC has state plan to increase reimbursement rates by Oct. 2024

- P3 Policy Impact Center supports:
 - Gathers info from state & county departments
 - Will be estimating, if everyone used <u>NAEYC standards</u> and <u>MIT cost of living</u>
 - Helping states show impact of investments over time
- Doulas will be added to the P-3 Policy Impact Center Roadmap
 - o Considerations: additions of midwives
 - Need for more research here because it's the only option for a lot of women
- P-3 Policy Impact Center webinar on tax credits to support families
 - Hispanic families are least likely to sign up for the credits they are eligible for
- Will paid family leave result in less need for the infant/toddler slots?
 - Something to consider
- We can reach out to PN-3 center for additional support; would like to see the report from VA
