### 1. Welcome from Chairs

Kendra Dunn welcomed new members and reminded attendees that a request for data on financing of home visiting models had been sent out.

## 2. Introductions

Shannon Wilson shared that there would be an ECLC meeting on the afternoon of February 29th. They would be discussing subcommittee priorities and how to seek more cohesion between the ECLC workgroups – by checking in more frequently and making sure needs get met across groups.

# 4. Work Group Updates and Discussion

Each work group (Availability, Collaboration, and Innovations, Finance and Funding Opportunities, Qualified Workforce, and Outreach and Advocacy) reported on draft 2024 priorities. Individual attendees then provided feedback on priorities and workgroups met in breakout rooms to revise plans based on input from colleagues. ## 4. Data and Evaluation Group Proposal and Vote

Trent Lalonde presented ideas on what the HVITF data working might focus on and prioritize. His presentation was developed in collaboration with other HVITF participants and based on feedback from a prior task force meeting. The proposal was to form a data working group that: schedules, formalizes, and documents what is already happening; makes the best use of Task Force members' expertise; alleviates the data-project demands of current working group members; and promotes data consistency and self-evaluation.

Members voted on the proposal: 17 votes in favor, no one opposed, no one abstained
